- Define standards and direction of architecture in the specific business or technical domain. -Define and develop the logical design and information management strategies necessary to store, move and manage data in a new target state.
- Incorporate digital and data technology directions thinking of current and future state into solution architecture design, while communicating and engaging Novartis Enterprise Architecture leadership and governance.
- Utilize architecture patterns to suggest the most adequate utilization of technical platforms in support of the holistic solution architecture design.
- Define, create, and evolve the Architecture Governance Framework (e.g. roadmaps, architecture methods, practices, and standards) additionally identify opportunities to improve the end-to-end process for architecture design for **Medical and Market Access** full portfolio.
- Collaborate with the business and domain architects to define standards and specific solution based on Novartis standards.
- Overall Understanding of Commercial Pharma Architecture and how content management, data flows and cloud-based interactions for information capture and usage for Medical and Market Access processes can work.

Pricing, Gross to Net, Revenue Forecasting, Reverse Logistics etc.)
