- Plan and manage the GMP analytical activities (releases, method validation etc...) for a timely delivery of results
- Write, review and/or approve analytical documentation in timely and high-quality fashion, such as releases, analytical batch records, etc. ensuring compliance with Novartis and health authorities' guidelines
- Provide scientific guidance to the laboratory associates
- Manage interactions and contribute to a high level of collaboration with internal and external stakeholders.
- Evaluate and implement new analytical methodologies for GMP purposes.
