- Should have sound knowledge about the Nomination of all participants in the QMS change phase from reviewer approver.
- Should be good in all Engineering related changes which requires an evaluation & followed by a Registration Representative
- Changes to ER/ES relevant systems, must be evaluated by eCompliance
- In the case of devices, a DHF (Device Documentation File) evaluation may also be required. In the case of combination products, assembled and/or packaged, the MS&T "device expert" must check for adjustments with regard to device documentation (DHF file).
- Implementation of the change and processing (or delegation) of the tasks defined in the implementation plan
- Coordination of the change until completion
