Review/Approve Civil/Structural/Building elevation drawings & documents supplied by the consulting firm and Ensure Quality construction standards and the use of proper construction techniques. Perform in – depth review of the project to schedule work and estimate costs. Supervise all onsite and offsite constructions to monitor compliance with building and safety laws. Perform due diligence for identifying latest construction trends, material, quality, reliability, cost etc.

Prepare drawing and documents required for statutory approvals. Conduct, minute weekly project coordination meetings with all the consultants, contractors. Mediate any conflicts that are arise with various contractors and consultants and Participate in resolving any technical hurdles during project executions with the help of consultants

• Ensure that construction activities move according to predetermined schedule. Communicate effectively with the contractors responsible for completing different phases of the project. Co-ordinate the efforts of all parties involved in the project, which include the architects, consultants, contractors, sub-contractors and laborer's'. Supervise the progress of the construction activities on a regular basis and hold regular status meetings with

all the sub-teams. Maintain strict alignment to the budgetary guidelines, quality and safety standards and Periodic inspection of construction sites. Ensure project documents are complete.

- Ensure compliance to all statutory requirements. Following & documenting the Project Change control management as per the agreed procedures and A Civil Project Engineer is expected to communicate the task in the best possible manner.
